INSTALLMENT POLICY OF THE COLLEGE

Introduction: At S. S. Dempo College of Commerce & Economics, Cujira-Goa, we understand the importance of providing convenient and flexible payment options for our students and their families. To ensure that education remains accessible to all, we have developed this Instalment Policy that outlines the terms and conditions for instalment payment plans for tuition and other related fees.

Eligibility: This instalment policy is available to all enrolled students of the aided and self-financed programmes at S. S. Dempo College of Commerce & Economics, Cujira-Goa who face financial difficulty in paying the programme fees. Students who wish to avail themselves of the instalment payment plan must meet the following criteria: a) Must be enrolled in the full-time programmes at S. S. Dempo College of Commerce & Economics, Cujira-Goa. b) Must have no outstanding financial obligations from previous terms. c) Must submit a completed instalment payment plan application.

Payment Schedule: Students approved for the instalment payment plan will be required to make payments according to a predetermined schedule. The instalment schedule will be communicated to the student upon approval of their application. Instalment payments will be due on specific dates throughout the academic term or year, as determined by the college authorities. Failure to make payments by the due dates may result in late fees and may affect the student's enrolment status.

Application Process: Students interested in enrolling in the instalment payment plan must submit a completed application form to the college office for approval by the principal. The application form should include the student's personal information, program details, and a proposed payment plan. The college authorities will review the application and notify the student of the approval or rejection of their instalment payment plan request.

Late Payments: Students are expected to adhere to the agreed-upon instalment schedule. Late payments may be subject to a late fee, as determined by the college authorities. Continued failure to make timely payments may result in additional penalties or the termination of the instalment plan.

Termination of Instalment Plan: The instalment plan may be terminated if a student fails to comply with the terms and conditions outlined in this policy. Upon termination, the outstanding balance becomes immediately due and payable. The student's enrolment status may be affected if payment obligations are not met.

Changes to the Instalment Policy: S. S. Dempo College of Commerce & Economics, Cujira-Goa reserves the right to modify this instalment policy at any time. Students will be notified of any changes to the policy in a timely manner.

Confidentiality: All personal and financial information provided by students during the application process will be treated confidentially in accordance with applicable privacy laws and regulations.
