

CIRCULAR

In accordance with the Special Ordinance OS-1 relating to the conduct of Examinations during the Covid-19 pandemic, the University Examination (Theory & Practical) for Under-Graduate Programmes of General Education B.A/B.Sc. (Including Home Sc.)/B.Com./B.C.A./ B.S.W./B.Voc. for the first half of the Academic Year 2021-22 shall be conducted in PHYSICAL/OFFLINE mode for Regular/Repeat & old/new course students.

The following guidelines are to be adhered to for the conduct of the examinations:

- 1. The Examinations shall commence from the 14th January 2022 onwards.
- Colleges shall conduct all the Semester End Examinations including Repeat Examinations and then upload the ISA/Practical marks obtained by the students of Semester V and VI on GUMS and submit the hard copies of ISA/Practical/SEA marks to the Examination Section on or before 1st March, 2022 for declaration of results by the University.
- 3. The duration of the examination shall be as per the relevant Ordinances.
- 4. There shall be only one Question Paper per subject per college.
- 5. The practical component examination also shall be held in physical mode.
- 6. The Question Papers for the ongoing semester will be set and evaluated by the teachers of the respective Colleges.
- 7. In the following situations, the Principal will appoint the paper setter cum evaluator:
 - a) If the course is being taught/has been taught by more than one teacher.
 - b) If the teacher/s who had taught is/are no longer associated with the College.
- 8. The teachers teaching a subject on lecture/contract basis will also be eligible to set and evaluate the concerned paper.
- 9. The Time-Tables for the various examinations in the current semester shall be prepared by the respective Colleges depending upon the number of students ensuring that social distancing is maintained. The Colleges may conduct the examinations in suitable number of shifts per day taking into consideration the space and infrastructural facilities available.
- 10. Use of facial masks, sanitizers, sanitization of classrooms and all other necessary precautions will be compulsory as per COVID-19 prevention norms.

- 11. There will be no revaluation or challenge evaluation for papers of Semester V/VI. Instead, the provision of personal verification available in the Ordinance and provided to Semester I to IV students shall be followed for Semester V/VI. students (the procedure currently followed for Semester I to IV is to be followed).
- 12. The examination will be of 80 marks for the SEE component as given in Ordinance OC-66.
